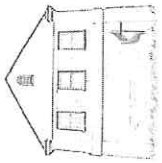

Volunteer Agreement: As a volunteer with Good Neighbor Settlement House, Inc. you consent to:

1. Treat all guests, staff and other volunteers with respect
2. Honor the Good Neighbor Settlement House 48-hour cancellation policy when possible
3. Closed-toe shoes and appropriate clothes are required; tank tops and shorts/dresses **ARE NOT ALLOWED!**
4. We reserve the right to have you not volunteer under our discretion
5. Good Neighbor Settlement House is not responsible for any lost/stolen items.
6. If you are not comfortable with any assigned task, please notify our staff.
7. You are required to stay the entire shift, unless prior arrangements are discussed.
8. Please be prompt when being dropped off and picked up.

Waiver and Release: Volunteer does hereby release and forever discharge and hold harmless Good Neighbor Settlement House and its successors and assigns from any and all liability, claims and demands of whatever kind or nature, either in law or in equity, which arise or may hereafter arise from Volunteer's work for Good Neighbor Settlement House. Volunteer understands that this Release Discharges Good Neighbor Settlement House from any liability or claim that the Volunteer may have against Good Neighbor Settlement with respect to any bodily injury, personal injury, illness, death, property damage, or any other liability that may result from Volunteer's work for Good Neighbor Settlement House, whether caused by the negligence of Good Neighbor Settlement House or its officers, directors, employees, agents, or otherwise. Volunteer also understands that Good Neighbor Settlement House does not assume any responsibility for, or obligation to provide, financial assistance or other assistance, including, but not limited to, medical, health, Worker's Compensation or disability insurance in the event of injury or illness.

Sex Offender Registry: I attest that I have not been charged with or convicted of, a sexual offense in any jurisdiction, and am not a Registered Sex Offender. I understand that GNSH reserves the right to vet volunteers through the National and Texas Sex Offender Registries.

Relationships with clients: I understand that in the interest of maintaining client' privacy and to allow them the space for transformation, it is important that I never cross professional boundaries with clients, which would include giving things of value to clients; giving rides to clients; or engaging in social activities with clients other than events sponsored by GNSH. I also understand that an individual who has a pre-existing personal relationship with a member currently residing on the GNSH campus or a guest in the courtyard may not be eligible to volunteer at GNSH. I do not currently have such a relationship and will inform the GNSH Volunteer Manager if, at any time, this statement becomes untrue.

Photographic Release: Volunteer does hereby grant and convey unto Good Neighbor Settlement House sponsors and their agents all right, title, and interest in any and all photographic images and video or audio recordings made during the Volunteer's work for Good Neighbor Settlement House, including, but not limited to, any royalties, proceeds or other benefits derived from such photographs or recordings.
